Motion by Pearson, seconded by Anderson, to table the HLW Financial Assurance Summary until the tentative April 11, 2024 meeting. Motion carried.

Motion by Hilmer, seconded by Richter, to table the approve transfer of funds for closure/post closure FY 2024 until the tentative April 11, 2024 meeting. Motion carried.

Motion by Surber, seconded by Richter, to elect Steve VanDeWalle as Vice-Chairman for FY 23/24 to replace Gordon Fassett who went off of the Commission. Motion carried.

Motion by Faircloth, seconded by Surber, the following appointments to the Budget Committee: Dave Sherwood, Bryan Ellenbecker, Bart Jensen & Curt Hilmer who will be replacing Dan Anderson. Motion carried.

Motion by Jensen, seconded by Faircloth to increase the part-time employees & Secretary/Bookkeeper by 8% to follow the Counties recommendation effective July 1, 2024. Motion carried.

Motion by Richter, seconded by Hilmer, to approve the Administrators recommendation to increase the Scale Operator to \$24.00/hour plus longevity and additional 8% increase to follow the Counties recommendation effective July 1, 2024. Motion carried.

The employee handbook was reviewed, and the following changes were proposed: change probationary period from six months to sixty days; allow employees to receive benefits and vacation time after the probationary period is complete; and allow the Landfill Administrator to extend the probationary period up to ninety days, if deemed necessary. Motion by Hilmer, seconded by Faircloth. Roll call vote with all voting aye.

Motion by Richter, seconded by Hilmer, to accept the bid from Kameron Koster to lease the landfill ground for a period of three years at a cost of \$250.00 per acre. Motion carried.

Motion by Anderson, seconded by Raymond, to extend the Recycling Contract for one year ending June 30, 2025 with contract terms same as current contract. The motion passed with 10 votes in favor and 1 abstained. Jensen abstained due to having current contract.

Motion by Richter, seconded by Faircloth, to table the review of the By Laws until the next tentative April 11, 2024 meeting. Motion carried.

Motion by Hilmer, seconded by Anderson, to not remove late charges on the Iowa Demolition account. Motion carried.

Motion by VanDeWalle, seconded by Surber, to approve Resolution 2024-01 as follows: The Tama County Landfill Commission authorizes the Tama County Auditor to pay all bills and payroll that have been approved by

the Administrator and/or Secretary/Bookkeeper prior to audit by the Landfill Commission at their regular meeting. Motion carried on a roll call vote with all voting aye.

Motion by Hilmer, seconded by Anderson, to adjourn until a tentative date of April 11, 2024 at 5:30 p.m. at the Tama County Landfill in Toledo. Motion carried.
